## SENATE ORDER FOR ENTITY CONTRACTS LISTING RELATING TO THE PERIOD 1 JANUARY TO 31 DECEMBER 2020

Pursuant to the Senate Order for entity contracts the following table sets out contracts entered into by the Royal Australian Mint which provide for a consideration to the value of \$100,000 or more (GST inclusive) and which:

- (a) have not been fully performed as at 31 December 2020 or;
- (b) have been entered into during the 12 months prior to 31 December 2020

Most of the Contracts listed contain confidentiality provisions of a general nature that are designed to protect the confidential information of the parties that may be obtained or generated in carrying out the contract.

- ordinary commercial prudence that requires protection of trade secrets, proprietary information and the like; and /or
- protection of other Commonwealth material and personal information.
